Discussion regarding "new business" that was not known about or which could not have been reasonably foreseen prior to the time of posting the agenda in accordance with Title 25 O.S. § 311(A)(9):

Amber Abbott introduced herself as a visitor to the meeting and owns property in Pontotoc County. Abbott claims the Pontotoc County Assessor's Office in the last few months has denied her access to her property records. She stated she has not been able to receive these records in person, by phone, or by email from Assessor Renae Furimsky or First Deputy Jay Owens. Abbot claims they are failing to comply with the Open Records law due to a personal issue.

Furimsky responded by saying she has told Abbott she may email or phone the office and request the information she needs and she will provide it.

Phillips stated she and D.A. Erik Johnson were notified of this issue and have not seen where Abbott has been disallowed her property records. Also, she stated there is an area for the public when you enter the Assessor's Office separated by double doors from the employees' area. Phillips said there was a clear course of action that she had received what she needed and can now move forward.

Starns confirmed with Abbott and Furimsky that she understands she can request/submit what she needs and they will provide it.

Paula Christian, Election Board Secretary, announced the filing period for the offices of the Court Clerk, County Clerk, District #2 Commissioner, and County Sheriff is April 3rd, 4th, & 5th.

Bolen stated as a reminder there will be a special BOCC meeting on Friday, April 5th at 9:00 AM at the Agri-Plex regarding the Avangrid wind farm project.

Motion by Bolen, second by Starns, to adjourn. All aye.

April 5, 2024

The Board of Pontotoc County Commissioners met for a special meeting. The time, place, and agenda were duly posted on March 27, 2024 at 301 S. Broadway, Ada, Oklahoma.

Discussion with Representative Ronny Johns, Senator Greg McCortney, and landowners regarding the wind farm/turbine project(s) in Pontotoc County:

Tim Curtis stated he was unaware of the wind project in the county. He works in the mining industry which requires safety, health, and environmental regulations. He stated these wind turbines should also be regulated the same way. He stated there is no authority at this time to make sure these wind turbines are regulated. They cause the destruction of property, endanger species, and affect generations of families. These turbines do not benefit our county. They can also cause contamination to our water from the Aquaphor and cause water wells to go dry. They cause turbine syndrome, which is insomnia, vertigo, pressure in the ears, etc. This all affects the people of Pontotoc County. Who is going to take a stand to stop this?

Trudy Mills a registered nurse for thirty-one years and now a rancher and beekeeper lives close to where the wind project is going. She stated most of the residents/citizens of Pontotoc County do not know/did not know about the wind turbine project. Trudy made references to the Facebook Group called "Save Oklahoma Farms and Ranches" and a YouTube video called "Blown Away" by Tucker Roberson. She also said there are reports from De Nina Pierpont that explain Wind Turbine Syndrome, which causes health problems such as vertigo, nausea, tachycardia, issues with inner ears, sense of motion, balance, and memory. If people with these problems spend days away from their homes where the turbines are many times go away. There is also a pulsating light known as shadow flicker. Ground water wells and the Aquaphor will be contaminated. BPA is damaging to the reproductive system and PFA is a toxic chemical and is associated with these turbines. She mentioned a book called "Big Winds" by Mark Welton and a video commercial by Governor Frank Keating.

Kyle Lown thanked the BOCC for making this special meeting happen. He stated that Avangrid Renewables LLC did not have the common courtesy to have a representative at this meeting. This company was saying they had been to these residents' houses twice per residence. Kyle said there was no contact made with him and other neighbors at all before they removed 600 of his trees and damaged his property. They told him they would make it right and offered \$2,500 for his tree damages to his property and 100 sapling trees. Avangrid has been secretive about the whole thing and there is a lack of communication. They have ruined his property and caused neighbors against neighbors. The kickoff construction by Avangrid is in July. Kyle asks for a moratorium to be put in place and if the County could seek jurisdiction to have authority over this matter. He stated, "Please protect us!"

April Ellis Jane stated Harper, a former Commissioner in Indiana, told their story about a wind energy company starting their project in 2011 with very little rejection on the project. A majority of the people did not realize how they would be affected. These residents no longer have birds come to their feeders, people cannot sleep, there is shadow flickering and they have lost the attraction to their property. April asked to not make the same mistake and experience this negative impact.

Calvin White was contacted by Melissa Veal about going to the meeting so he did. He lives three miles north of Roff and breeds Quarter Horses and doesn't know what kind of impact it will have on their horses. He is also concerned about his grandkids. Some of his neighbors/friends kept the wind project undercover so he did not know about it until Easter Sunday. He does not want this and is offended that neighbors would do this for money.

Will Chaney is in the footprint of this project and just found out about it. He is very concerned about the transparency of this project and how there is no oversight. He doesn't know how lives will be affected. He is not mad at the neighbors who signed in favor of this. He is upset about how this was handled in secrecy and whoever has the authority to oversee this please make it better.

Carlene Henderson found out one week ago about this wind project and questions if there was research done. What is going to happen? How will groundwater be affected? It will be contaminated. How will electric bills be affected? The energy produced will not help residents., it will help the company and other places. She is concerned about how it will affect her grandson. The value of their property will decrease. The grass for cattle will be affected, which will affect how we eat. Only a handful of people know about this. Why isn't this voted on? She doesn't want her family or community to be put in danger.

Roland Ventske doesn't like how neighbors just care about the money and aren't helping others out. How is this going to help the county?

Tim Henry is retired after thirty-seven years for OG&E. He said according to the Avangrid website, there are thirty-three wind turbines in Pontotoc County, that provide power to 40,000 homes, but the power is going to NE states, not Oklahoma.

James Edwards voiced his disgust with this project and the people. He had to get on city water because his well went dry. He received a call from them, but he said no! You can get

information at duckduckgo. This is being pushed by underhanded people and the electricity isn't even going to Pontotoc County.

Kelly Cope moved here from Houston, Texas, and worked in the energy business. This is due to the Inflation Reduction Act that passed for tax credits. This is a government handout for green energy. In Tulsa, OK a wind farm company called Enel Green Power North America did not get permission to obtain mineral rights where they were located and was ordered to deconstruct eighty-four wind turbines at its Osage County wind farm. He claimed our local tribe could take a stand on this. Transmission lines are used to support wind farm development and when building them if the landowners won't agree to the company's terms they will use eminent domain. Eminent domain allows them to take your property and you can't do anything about it. This is not at all for our benefit. This gives tax credits to foreign people.

Linda Edwards moved here forty-five years ago and said there have been twenty-eight turbines installed in Murray County that have ruined the beautiful Arbuckle Mountains. She said they had one meeting before putting the wind farm in Murray County. Only the companies benefit from this.

Don Veal stated representatives were contacted five years ago when they tried to put turbines up in Edmond City limits were extended to stop it. He said elected officials need to help.

David Lucas said in 2000-2001 windmills were put in Weatherford, OK. Now there is nothing but windmills. There are windmills to the south of his house one mile from Fitzgugh. Has anybody submitted the request if an environmental study on these wind turbines has been done? Do they have a mining permit within the county? The wind turbines affect wildlife and air flows. This is a problem for Roff and surrounding areas. What is going to happen in eight to nine years when the blades have to be replaced? Where will they put the used ones? He said the motors are taken to Catoosa to be destroyed. They claim to be environmentally friendly, but they are not! They make it hard for the farmers and other people to refuse the money, but he is against it.

Richard Medcalf said he has seen at Sulphur that the permanent jobs that were promised are not there. There may be about fifty people working temporary jobs. Turbines, electric cars, and solar panels all need batteries. China has seventy-five percent of the minerals for these batteries. This could give China control of our electric power usage.

Stacy Moore stated Avangrid representatives are not here. They came to her property at the end of January. When she spoke with Avangrid project manager he advertised it would create 200 jobs, but instead, it will provide about eight permanent jobs. She also said you can access a Facebook page called "Protect & Preserve Pontotoc County." Governor Stitt says 70% of the power that we create goes out of Oklahoma. She asked, "Have we not learned from the marijuana farms?" They turned into a mess. A lease of forty years plus on turbines without any County or State permits should not be allowed. Wind turbines should be done responsibly. Stacy provided handouts to look at. She asked should this happen to our community. Please protect us all!

Representative Ronnie Johns expressed his thanks for coming to them. They elected him and he will do what he can to fix this. He remembers in 2018 Don Veal called and asked him for help with the wind farms around Mill Creek. Johns did not know about Avangrid coming to this area until he was contacted about attending this BOCC meeting. He stated there is a Senate Bill coming up about the wind turbine lights. He appreciates the community coming together. He will check with other counties that have been through this. Lincoln County has been through this and will contact them. Please let him know about any communication with Avangrid. Email is ronnie.johns@okhouse.gov, phone number is 405.557.7336. He reached out to Avangrid 's liaison and he agrees they have not communicated well at all.

Senator Greg McCortney stated he would represent the community. Starns reached out to him to ask about the wind farm around Roff. Avangrid representatives are at the capitol and admitted they have not handled this well. They are planning on moving forward quickly in July. McCortney explained Pontotoc County has not had to deal with this and we need to have information from the ones that have had experience with this. Rights are being infringed and residents need to go to the judicial system. The blinking lights on wind turbines are being addressed on a bill that passed through the Senate and now at the House. There is technology to stop the blinking lights. He said the worry is this bill is not going to be in effect before they start building the wind project. If the project can't be stopped, hopefully, the blinking lights will at least be stopped. The creation of jobs is not as advertised. The electric power goes out to multiple states from the pool it goes into. Once the power goes into the pool it goes everywhere. Our electric bills will not be decreased and jobs will not be produced. This is a learning curve and nobody knew this was happening before it started happening. You can email McCortney at

Randall Christy provided a letter because he could not be here at the meeting. There is no approval for this wind project. We have to fight on a County and State level. A resident stated people and cattle rely on RWD #8 well water. Are there any Federal or State regulations that have to be provided showing this project will not damage the water resources?

Kyle Lown said it is unfortunate the only recourse is to sue. Ten people have made a class action suit against this company. Starns said he has been on the ACCO Board since 2000 and has seen residents be promised by companies that they will maintain the roads for their projects and they don't. Many county dollars are spent on maintaining roads. The BOCC can't just jump in and stop this. The City has different regulations than the County. Radio towers are regulated by the State. Oklahoma Corporation Commission is supposed to regulate.

How are wind turbines taxed? Commercially? Ronnie Johns said Roff School will reap large benefits if the wind project goes in. In Johnston County, the original company did not provide the funds to Mill Creek School as they should have. Then that company is sold to another company and the school does not receive the benefits they should. What is the actual footprint area of this project? It is from Dolberg Road, Roff to County Road 3420, and includes the northwest corner of Roff.

Cody (last name is unknown, he did not sign in on the sign-in sheet) asked if we even had a leg to stand on. D.A. Erik Johnson stated the original involvement was the road usage agreement. Yes, we have a leg to stand on for this agreement, yes for the Aquaphor, yes to damage of the roads, and yes for the Osage Nation court case. If we talk about bugs or birds, no, probably not. A special counsel needs to be brought in to help with this.

Kyle Lown asked if anyone had reached out to the Chickasaw Nation for their assistance. OG&E and PEC will receive revenue from this. Money is the only good thing about this project. Garvin County has an agreement with this company to come in through their county to install the wind turbines. The agreement says they can't cross any weight limit bridges. Ronnie Johns and Senator Greg McCortney were thanked for attending the meeting so they (residents) could be heard.

Teel spoke with the foreman and the grader operator and then came to her car window and explained that construction vehicles always have the right-of-way. Teel gave her the report and she went home. Davis explained how when operating a road grader, the driver is watching the blades while driving and there is also a large blind spot especially if someone is following closely. Cooper stated she just wanted her side of the story to be heard and wanted to know what she should do if this were to happen again. She was informed again that construction vehicles always have the right-of-way.

Brown explained to the BOCC that Stonewall VFD had ordered a 2023 cab & chassis last fiscal year on State bid, but was never able to get one due to vendor availability. That purchase order was canceled and a new purchase order was encumbered for FY 2023-2024. Brown was contacted by the vendor that they could provide 2024 cab & chassis, but not a 2023, which would increase the price by the current State bid. The BOCC stated if they needed to get a new request to get a purchase order for the current amount and cancel the previous purchase order they were good with it, but would like to confirm with the auditor's office.

Trudy Mills referred to an incident written about in USA Today involving wind turbines and how they would harm the region in Indiana. She read about how the County Commissioners in the state of Indiana were able to ban this project. She also asked for any update on a moratorium and what the procedure is to bring something like this to the vote of the people. She also asked about the initiative petition procedures. Krystina Phillips, Assistant D.A., stated she could assist with that procedure information. Phillips also stated D.A. Erik Johnson has reached out to attorneys specializing in wind turbine projects. When Johnson returns from being out of the country there will be a conference call about this.

Danny Manuel, 911 Director, announced he submitted a letter to the Ada News in regards to the tabletop training exercise for Pontotoc County if there was an F3 tornado. This exercise took many hours of preparation and planning and was a success. The teamwork was incredible and the BOCC was recognized for being so involved in this exercise.

Tim Mills stated he was not here to attack anybody and asked if anyone had read the road agreement. Phillips told him she had made many adjustments before approval. Mills asked if an insurance bond had been received. There has not been a bond received so he said that is a breach of contract. Also, he brought attention to the fact the agreement stated no equipment allowed on the roads more than 54,000 pounds, but there is a picture of a 55,000-pound track hoe going down the road and that is also a breach of contract. Did it have a preconstruction survey or did they turn in a certificate of general liability, if not that is a breach of contract. The fine print in Section L of the agreement was questioned and Phillips said she would review the agreement again.

Stacy Moore stated they (the wind project company) have to have a public meeting either seventy or ninety days before construction can begin. Also, two maps are going around. One is a lease map and the other one is a project area map. She stated the county did not receive the contract back until April 11th and they did not date it when they signed it. There have been nine amendments filed and there are discrepancies in the maps. The BOCC was asked to read through the agreement closely and Bolen stated they presented the agreement to the D.A.'s Office for approval.

Trudy Mills requested the item of the wind project to be put on the BOCC agenda for next week, April 22^{nd} and we confirmed. Mills said they are in breach of contract on this agreement for road use.

Discussion, consideration, and possible action with Kyle Lown & Stacy Moore regarding Authority Having Jurisdiction (AHJ) and a planning committee:

Kyle Lown stated at the April 5, 2024, special BOCC meeting they were requesting AHJ and are asking again today. They would like the BOCC to please review the AHJ handout which has information about AHJ that he and Stacy provided and request to be on next week's agenda and vote on accepting it. Also, provided was an unapproved copy of a resolution with Adair County adopting the AHJ. They are also currently working with Murray County to join AHJ. Lown said it gives the County the power to protect itself since the State is not.

Residents plan to form a planning committee with oversight by the BOCC. It would give the County's governing body the ability to protect the County if the BOCC approves.

Jimmy Morgan, a resident, asked who would be on the committee and what would the committee do. Lown responded that the citizens of Pontotoc County may be on the committee if approved, but there are no answers yet on what exactly the committee would do. They would have to come up with a plan and submit it to see if the County wants it or not. Morgan confirmed if they would be asking the BOCC for guidance and Lown agreed. Lown also stated he has been in constant contact with Ronnie Johns.

Starns stated there are pros and cons and asked who would be paying for AHJ to help. Lown said that is also what the planning committee would figure out, but the County should not have any cost. Starns stated they should be working with State legislators/State Capitol and not AHJ because they make the laws and can make changes. A lot of the reason legislators don't do anything about this wind farm issue is because the wind farms give them a lot of money.

Davis asked what other counties have used AHJ.

Calvin White, a resident, said he doesn't want to see or hear the wind turbines.

Krystina Phillips, Assistant District Attorney, stated they are willing to have a tool to protect the County, but the BOCC will need to know all the pros and cons before deciding about AHJ.

Morgan asked if the Chickasaw Nation had been contacted, and Lown said he had been in communication with them. No action.

Discussion, consideration, and possible action with RWD #6 and the engineer regarding the upcoming project/bid:

Gary Kinder, Triple E Engineering Engineer, stated he knows RWD #6 has been allocated \$250,000.00 in ARPA funds, and anything \$25,000 or more has to be bid. The bid specifications are being submitted for materials for three projects. A grant for RWD #6 may be used for labor. Motion by Davis, second by Bolen, to approve to move forward with bid procedures for RWD #6 projects. All aye.
