REAP 2017 – District #2

District #2 has been awarded **REAP Grant #17-038** in the amount of \$10,971.00 for a road project to add two layers of oil and chip to one mile on County Road 3450 and County Road 1470.

Project was completed, funds were received May 6, 2019 and grant was closed-out May 13, 2019.

REAP 2018 – District #1, #2, #3

Awarded to all three districts on January 4, 2018 through December 31, 2018 in the amount of \$50,000.00 (to be divided by all three districts) for road projects.

District #1 – **REAP** #18-045 – Project would be to patch and chip seal County Road 3645, Owl Creek Road,

Road project was completed and request for funds submitted August 2018. Funds were received July 1, 2019 and Close-Out Certification was signed July 8, 2019.

District #2 – **REAP** #18-046 – Project would be to oil and chip one mile of County Road 3518, between County Road 1570 and County Road 1580.

A grant extension to complete road project was received July 2, 2019 and extension is now to October 30, 2019. District #2 is now prepping road to then complete road project with oil and chip seal by October 2019.

District #3 – **REAP** #18-047 – Project would be to resurface and restore 1.2 miles of County Road 3640.

A great extension was received February 2019 and road project is now to be completed September 2019.

REAP 2019 – District #1, #2, #3

Awarded to all three districts on November 9, 2018 (didn't get letter until Jan. 17, 2019 though) through December 31, 2019 in the amount of \$12,299.00 each for road projects.

District #1 – **REAP** #19-021 – Project would be to patch and chip seal County Road 1495 east of Highway 1

Road project has been completed and District #1 is in the process of compiling paperwork to submit to SODA to then receive grant reimbursement monies.

District #2 – **REAP** #19-018 – Project would be to resurface County Road 3530.

Upon on no delays, District #2's road project is on schedule to be completed by December 31, 2019.

District #3 – **REAP** #19-034 – Prepare County Road 1650 with c-mix asphalt, completed with a 3/8 oil/chip seal.

Road project is to be completed by September 2019.

2017-2018 CDBG - District #1, #2, and #3

17006 CDBG 17 Grant was awarded September 29, 2017 through September 28, 2019 for \$150,000 (to be divided by all three districts) for road projects.

District #1 road project: asphalt overlay one mile of County Road 1500, with striping.

Road project has been completed, and funds were received August 31, 2018 in the amount of \$50,000.00.

District #2 road project: double layer of oil and chip seal 3.5 miles of County Road 3470.

As of June 28, 2018, District #2 road project was completed and is in the process of compiling paperwork and will then submit to request funds.

District #3 road project: double layer of oil and chip seal 3.3 miles of County Road 3460.

The Department of Commerce has granted an extension for Pontotoc County's grant until December 31, 2019. Upon no delays, District #3 is projected to complete road project by the middle to end of September 2019.
