Chad Letellier, Emergency MGMT Director, reported there was a significant fire between Union Valley and Stonewall this past weekend.

Rob Johnson stated it had been ninety days since the Ada Fire Department/VFD/s mandatory meeting with the BOCC about the issues and concerns due to a lack of response from the VFDs. It is time to meet again as agreed upon per votes of the BOCC and review to see if compliance has been met and issues have been resolved. The BOCC stated that this item will be put on the October 11th agenda, and they need a person from each fire department to attend the meeting. Chad Letellier will contact the appropriate people.

Jenny Lindsay, PCHD, stated they have available the COVID booster, Pfizer and Moderna. They are available from 9:00 - 11:00 AM and 2:00 - 4:00 PM on Tuesday, Wednesday, & Thursday at the Health Department.

District Attorney Paul Smith stated he had received a message from Wellon Poe, attorney for Pontotoc County that there will be a possible executive session on the Fontenot lawsuit put on next week's BOCC agenda. Poe plans to be strategic and active in what he is going to recommend. Smith will provide the BOCC's administrative assistant with the necessary language for the items to be placed on the BOCC agenda.

Also, Smith informed the BOCC he will have an opinion as soon as he can for the email request from the Board regarding the officers/elected officials receiving raises based on the new legislation and laws.

Discussion and possible action to vote to enter Executive Session pursuant to Title 25 O.S. 307(B)(4) to discuss with District Attorney, Paul Smith, and Wellon Poe of the Collin, Zorn & Wagner law firm (via telephone conference) the pending settlement action in U.S. Federal District Court (E.D.) Case: Fontenot v. Pontotoc County et. al. 21-CIV-249-KEW; if the public body with the advice of its attorney determines that disclosure will seriously impair the ability of the public body to process the litigation in the public interest. Discussion and possible action regarding the settlement of the lawsuit U.S. Federal District Court (E.D.) Case: Fontenot v. Pontotoc County et. al. 21-CIV-249-KEW:

Based on Collins, Zorn, & Wagner's suggestion, District Attorney Paul Smith and the BOCC affirmed and agreed. Motion by Starns, second by Davis, to dismiss without prejudice along with further engaging with counsel to monitor the case/lawsuit of Fontenot and consult as necessary about any new developments. Starns and Davis aye.

Discussion and possible action with the Fire Department's Fire Chiefs and Assistants regarding the ninety (90) days compliance period and the response to calls and funding:

Rob Johnson, Ada Fire Department Chief, referred to the fire department's meeting that was held three months ago about the lack of response from the VFDs and funding. At that meeting, it was decided to set up a ninety-day period to see if the issues they were experiencing could be resolved. At this time, Johnson stated these issues have improved a lot. There is a very small percentage that is still not responding according to Johnson, and he feels there should be some kind of compensation paid to the Ada Fire Department when necessary. Davis stated he thought the issues had improved also. Davis explained if Johnson feels it is necessary to bill a fire department for not responding or some other issue, he could request to be put on the BOCC agenda to discuss the issue and/or receive compensation if needed. Johnson also added medical calls definitely need to be responded to even if it is to just help medics as necessary. Johnson feels if the VFDs are receiving sales tax funds, they need to respond and do their job. The question was asked by one of the fire departments and the BOCC confirmed that if the County is being billed to compensate the Ada Fire Department for lack of response, the payment will be paid out of that specific VFD's account.

Danny Manuel, 911 Director, suggested another way to help resolve these issues is mutual aid discussion between the fire departments. No action.

Quarterly Meeting for Pontotoc County personnel - Discussion and possible action regarding the following items:

- Building Maintenance Protocols:
- 1. Each office is responsible for calling the vendor they need to handle their issue.
 - a. At that time, they also need to get an estimate from their vendor so they will know how much to encumber for their purchase order.
 - b. Notify the vendor that the billing address will be your office address so the invoice will come to you and you can follow up/confirm the invoice has been submitted and paid.
 - 2. Complete and turn in a Purchase Order (PO) Requisition Form to the purchasing agent (the same day you call your vendor). When completing the form, the Requisitioning Department will be BOCC and the account will be County General 0001-1-2000-2005.
 - 3. Contact the BOCC Chairman (the same day you contact the vendor and submit your PO Requisition Form) either by text or calling their county cell phone so they are aware of the issue, and know to go by the Clerk's Office to sign the PO Requisition Form. (The BOCC Chairman changes every January. See list below)
 - 4. Confirm the invoice has been submitted and paid to prevent unaccounted POs at the end of the fiscal year.

b. *Purchasing:* New laws will be effective November 1, 2022 (House Bill 3344). Heavy equipment (in excess of 10,000 lbs.) and not to be estimated in excess of \$30,000.00 regular purchase order and does not have to be bid. In an excess estimate of 30,000.00 should be a blanket purchase order. Reminder – regular repairs to equipment, (remains the same) machinery or vehicles can go on a purchase order for \$10,000.00. If estimated over \$10,000.00 repairs it has to be on a blanket purchase order. Reminder – November 1, 2021 the purchase limit increased from \$15,000.00 to \$25,000.00 (by department). If over \$25,000.00 it has to be bid.

c. *Inventory*: HB 3344 effective November 1, 2022 increased the inventory limit to \$2,500.00 (except for IT hardware it will remain at \$500.00). Existing inventory stays on the inventory list no matter the cost.

d. 2022-2023 Updated Pay Scales: Need to be updated and turned in to the County Clerk's Office. Once all have been received, the updated pay scales will be approved in a BOCC meeting.

e. *American Rescue Plan Act (ARPA) Funds of 2021Reporting*: Paula Hall, Treasurer, explained that we have received emails from the U.S. Treasury stating they do not have the funding for the aid and contact center to help with the reporting with the SLFRF (State and Local Fiscal Recovery Funds) Program. Hall stated this will cause the reporting to be more complicated as the County will not have this support and would like for this to be taken into consideration as that time nears. Hall also reported there is \$32,611.99 interest collected from these funds that may be used in any way needed.

f. *Courthouse Security Cameras*: Sheriff John Christian stated he has received quotes, but they did not include the County Clerk's Office and other offices that need cameras. More than half of the Courthouse cameras are broken and need to be replaced. The Court Clerk's Office also needs cameras replaced per Lacee Flanary, Court Clerk. The BOCC stated this can be paid out of County General funds. Christian said he will follow up on this.

g. 2022-2023 Budget: Tammy Brown, County Clerk, sated the FY 2022-2023 Budgets are in the process of getting ready to be filed with the State Auditor & Inspector. Raises in the amount of \$100.00 will be retroactive and have been figured in the FY 2022-2023 budget. The BOCC stated the 1st Deputies/Foremen will possibly not get the raise if the Elected Officials do not receive a raise.

h. *BOCC Meeting Agenda Items*: Reminder – the cutoff time and day to place an item on the BOCC agenda are at noon on the previous Thursday before the Monday meeting (If the cutoff time is altered due to a holiday, inclement weather, or some unforeseen issue the BOCC's Administrative Assistant will notify by email the change for that week). If you have an item, send an email requesting for your item to be put on the agenda to the BOCC's administrative assistant's email. If you do not receive a reply, follow up with her before the cutoff time and day.
